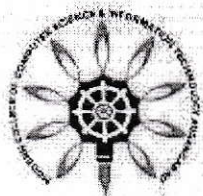

Visits

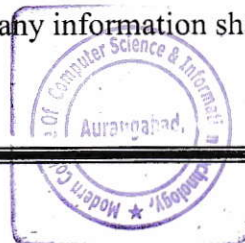
