2. Objectives

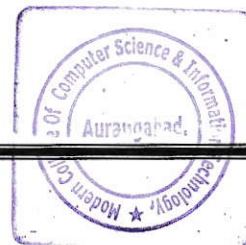
- a. Academic Collaboration: MC and HTIT will collaborate on academic programs, including joint research projects, faculty exchange programs, and curriculum development.

This MOU shall be effective from the date of signing and shall remain in force for a period of five (5) years, unless terminated earlier by mutual agreement.

4. Visits

- a. Faculty Visits: Both institutions may arrange for faculty visits to exchange knowledge, conduct lectures, and participate in collaborative research projects.
- b. Student Visits: Student visits may be organized for educational purposes, including industrial visits and cultural exchange programs.

5. Intellectual Property Rights
